## MEMBERSHIP LEVELS

### **Network** Members

Becoming a Network Member gives you access to all the membership benefits and demonstrates your organisation's commitment to child safeguarding.

### **Accredited** Members

KCS Network Members can choose to highlight the quality of their child safeguarding by applying to become an Accredited Member. KCS will review central level child safeguarding policies and procedures to assess how near or far an organisation is from meeting the International Child Safeguarding Standards. If satisfactory evidence is provided, the organisation will be awarded Accredited Member status and will be entitled to use the KCS Accredited Member logo, for all communications. Accredited Membership is the first step in verifying your organisation has taken significant steps to implementing child safeguarding.

## **Certified**

### Members

Member organisations that meet the quality assurance requirements of the KCS Certification scheme will be awarded Certified Member status.

This rigorous 10-stage process offers external verification by practitioners that child safeguarding measures are 'fit for purpose' and the right to use the KCS Certified Member logo, a visible symbol of quality performance in child safeguarding.

Corporate Member fees begin at GBP £10,000 and include all Network Member benefits as well as a tailored package to meet your organisation's needs.
